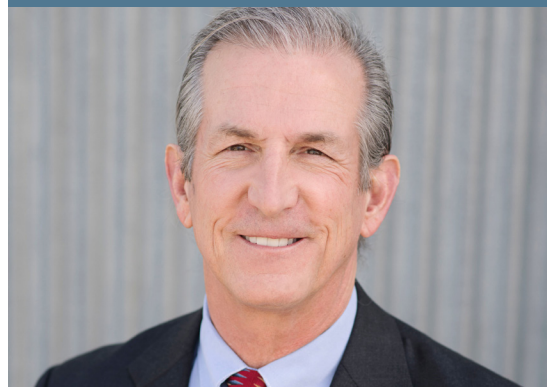
## CAREER HISTORY
